*Commodore's report – Simon Lidbetter***

Topic	Report
New Year's Day Racing	No racing held as the red boards were up, but around 20 people gathered for mince pies.
Winter Social	No winter social in 2022.
Spring Work Party	11 members turned up to help get the club ready for the new season.
Racing	Racing started in April. We lost March due to red boards.
Open Day	Held this year after a two year gap due to COVID. There were lots of helpers. Only 2 units joined on the day, but we had many join later.
Presidents Bowl	There were many capsizes
Summer Party	We had a hog roast and the event was well attended. Thanks to Alan Beeton for the loan of his marquee, which was very much need due to the afternoon/evening rain fall.
Regatta	The GTSC Regatta was held in September and incorporated the JMS Challenge and Barts Bash races. The JMS Challenge comprised a 3-leg relay of sailing/kayak/SUP and was excellent fun (to watch and participate in).
Laser Cup and Single-handed	6 lasers and 3 single handers took part
Race against Island	The first race in May (away) had 6 sailors and some supporters. The second race (home) in October was a good event and we kept the trophy.
Autumn Work Party	Well attended and lots of jobs were completed.
Waterfront	The timber along the frontage and up the slipways was replaced as planned and is looking very smart.
Decorator	A decorator painted the white timbers around the club house in the spring and it looks much better.
Safety boat	There is a new RYA regulation for power boats that requires the



	throttle to be in the centre of the boat. The throttle is being moved on the dory to comply.
Training	2022 was the busiest year for training and stretched the volunteers to the limit. Mark Foster has negotiated with ASSF for them to support all training in 2023. The 2-day RYA courses will be held as one-day on consecutive weekends so the club is free for kids club, racing etc.

Sailing Secretary's report – Neil Champion

Highlights for 2022

Water sports weeks	Second year of holding watersports weeks in April, July and August.
GTSC vs Island	The away leg in May saw 6 sailors/5 boats from GTSC. At the home leg in October there were 7 sailors/6 boats from Island. GTSC won overall.
Wednesday eve	The start time reverted back to 6:30 and 17 races were held.
Regatta	The weather was good and 8 races were held: Senior Moments, Novice, Junior/Youth, Bart's Bash (we raised £40), JMS Challenge and Parent/Offspring.

In total there were 28 different race championships/series (8 from the Regatta). 103 races held (up from 80 in 2021) with 66 different sailors: 41 adults and 25 juniors. Of these numbers there were 26 female sailors (16 adults and 10 juniors). Would like to encourage more female sailors. There has been a decline in the number of women taking part in key races.

There has also been a decline in the number of sailors in general across the key cup races over the last 3 years.

NSSA Regatta was held in Plymouth with 4 from GTSC.

Mark Foster put a lot of work into remodelling all the bookings through ASSF. They have full time administrative person.

4. Receiving the Report of the Treasurer and the audited accounts of the Club for the financial year last expired.

Thanks to Kathryn Foster for sorting out our corporate tax return (£53). Thank you to Maureen Witcher for doing the audit again this year. Maureen will stand down this year. A big thank you to Maureen for all her years of service.

JMi presented a summary of the accounts. The club is in a good financial position although there is a small deficit (£638.79) this year with ~£60K income and ~£60K expenditure. Significant capital investment was made and the big ticket items have been the frontage (£14K) – thank you to Peter Hunter who project managed the whole effort – new safety boat (£5.7K) and new Topper (£3.4K). We anticipate an increase in running costs next year.

The accounts were presented and put to the meeting. Proposed by Alan Beeton and seconded by Jo Almond. Carried unanimously.

Robert Harrison requested feedback on the Burgee. It is good as a written record of what does on during the year at the club. The Burgee could be posted as a flip book on the website.
